This Privacy Policy applies between you, the User of this Website, and West Coast Waste Managment, the owner and provider of this Website. User or you	any third party that accesses the Website and is not either (i) employed by West Coast Waste Managment and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to West Coast Waste Managment and accessing the Website in connection with the provision of such services; and

 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";

- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this Privacy Policy.

Scope of this Privacy Policy

- 3. This Privacy Policy applies only to the actions of West Coast Waste Managment and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

- 15. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.

Data Retention

Your Rights

- 20. You have the following rights in relation to your Data:

- 40. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
